In the event that you are locked out for nonpayment you have 14 days to settle account and remove goods from premises or goods will be disposed of at the discretion of Bonnie Doon Storage. INITIAL
You agree that if rent is 30 or more days late, Bonnie Doon Storage has the right to change the locks and dispose/sell goods. INITIAL
