AGREEMENT

BY AFFIXING MY SIGNATURE TO THIS DOCUMENT, I UNDERSTAND AND AGREE THAT I AM LEGALLY BOUND BY ITS CONTENTS.

- You agree to provide your own Lock, as well as a spare key which is held by Bonnie Storage. INITIAL_____

- All payments are to be made at the start of the lease in advance by you. INITIAL_____

- You shall not use the storage area for any other purpose other than storing the items mentioned above. (a workshop, a place of residence, and/or an Overnight stay)
INITIAL_____

- You shall not store any goods that are illegal, hazardous, flammable, and explosive or that may be a risk to any person or to the property of any person. It is also noted that all goods are stored at you sole risk. INITIAL_____

- If you are 14 days in arrears with rent, Bonnie Doon Storage may refuse you access to the storage space until all monies due have been paid. INITIAL_____

- In the event that you are locked out for nonpayment you have 14 days to settle account and remove goods from premises or goods will be disposed of at the discretion of Bonnie Doon Storage. INITIAL_____

- You agree that if rent is 30 or more days late, Bonnie Doon Storage has the right to change the locks and dispose/sell goods. INITIAL_____

- Bonnie Doon Storage does not insure the goods and is not liable for the loss of any goods stored on the premises. You will provide a copy of their insurance policy that covers the items being stored. INITIAL_____

- You agree not to damage, vandalise or steal anything from the premises and understand that CCTV can be used as evidence for tracking purposes. INITIAL_____

- You agree to give 14 days' notice prior to expiration of this agreement. INITIAL_____

- It is your responsibility to leave the area in a clean state, any removal of rubbish or discarded goods left on site will incur an extra cost to you. INITIAL_____

- You must notify the Bonnie Doon Storage immediately of any change of address or contact details and give a key to the agent if the locks are changed. INITIAL_____

- You understand and accept that in the event of a payment default action will be taken to recover any monies owed and any costs, fees, charges and interest associated with collecting the monies owed will be added to your account. In the event of a payment default you may have a default listed against you with a Credit Reporting Agency. INITIAL_____
